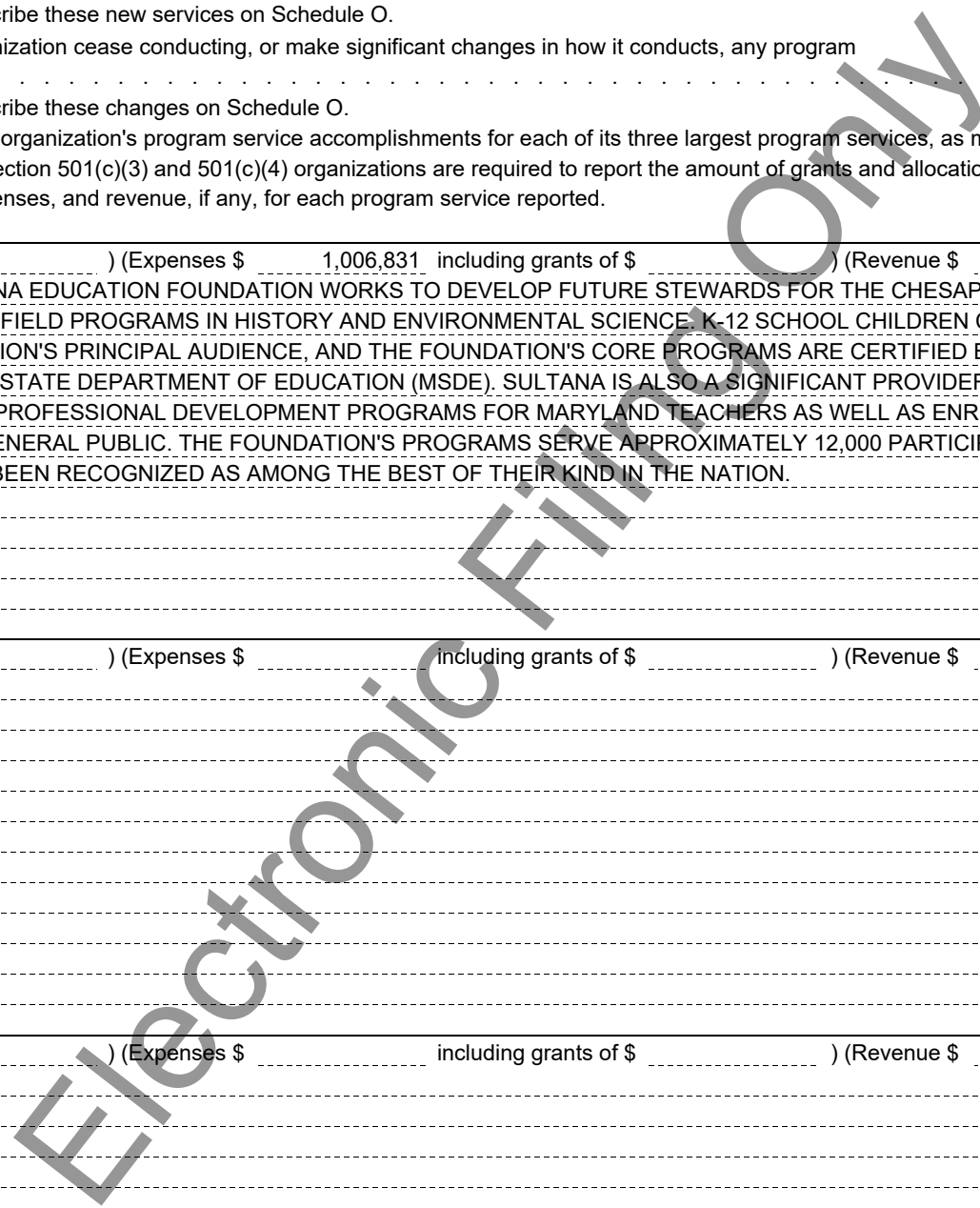

SULTANA IS ALSO A SIGNIFICANT PROVIDER OF MSDE CERTIFIED PROFESSIONAL DEVELOPMENT PROGRAMS FOR MARYLAND TEACHERS AS WELL AS ENRICHMENT PROGRAMS FOR THE GENERAL PUBLIC.
